MEMORANDUM: At Home Program's School-Aged Extended Therapies Benefit Authorization Period Update



May 2014

To: Parents and Professionals

RE: Extension of School-Aged Extended Therapies authorization period to a maximum

of 12 months.

To reduce the administrative burden for therapists, and to minimize the risk of service disruption, the maximum authorization period allowed for the School-Aged Extended Therapies benefit of the At Home Program has been increased.

Effective May 16, 2014 the maximum authorization period for the School Aged Extended Therapies benefit will increase from 6 months to 12 months. A maximum of \$3,840 may be approved for any one of occupational therapy, physiotherapy, or speech-language pathology. Up to a total of \$480 (within the \$3,840 maximum) can be used for consultation, report writing and travel purposes within that 12 month period.

A maximum of \$1,920 may be authorized for Chiropractic and Massage Therapy, per 12 month period.

All requirements for School-Aged Extended Therapies requests remain the same and there is no change in the maximum billable amount per year.
