# WHAT WE HEARD A STORY OF HOPE FOR A SCHOOL FOR DEAF IN WEST AFRICA

Sierra Leone is a small country on the eastern "hump" of West Africa. A former Britsh colony, it is about the size of New Brunswick with a population of 6,000,000 souls, more than half of whom are under the age of 15. This small, and sometimes forgotten, nation may only be remembered as one of the Ebola epidemic areas of 2014/15. Historians and movie buffs will recall the notorious and violent civil war of 1992-2002 that killed 50,000, maimed and displaced hundreds of thousands, the so-called "Blood Diamond War". Sierra Leone remains one of the poorest countries in the world, with low life expectancy, low education, and among the highest of maternal and under 5-year mortality rates. Support for those with disabilities is hard to come by and it is in the city of Bo where we came to hear about the Ebert Kakua School for the Deaf.

The director of the school, Sylvester Bob Deen, took over from the Eberts, a missionary couple from the US who founded the school but were abruptly recalled by their church. It has been a struggle. The Sierra Leonean government often lacks funding for the school and Sylvester has worked hard to make conenctions with organizations.

Margaret, my wife, and I regularly contact Sylvester and visit the school in our return travels to Sierra Leone. In 2012, we came with first year medical students from Calgary as part of their global health experience and had a chance to do basic ENT exams on some of the students. In February of this year, we visited the school and saw that it was keeping its head above water. The new dorms look great and the classrooms are abuzz with children, signing vigoursly in ASL to eachother and their teachers. The striking story here is that none of the children have ever had hearing aids and apart from the few students who had basic ear exams by the medical students, none have had a audiologic assessment.

This year we have been able to make contact with an organization from the U.K. called Sound Seekers (sound-seekers.org.uk). They are running hearing programs in Sierra Leone, including hearing screening

at schools, audiometric testing for the deaf, and hearing aid fittings. The program also supports a hearing education program at one of the universities in the north of Sierra Leone. Interestingly, Sound Seekers was not aware of the Ebert Kakua School, having worked with two other schools: St Joseph's in the northern city of Makeni, and the National School for the Deaf in Freetown, the capital.

Our goal now is to link with Sound Seekers for hearing assessments for the current school enrolment and identify which students will benefit from hearing aids. Then the real work begins with professional speech therapy, ongoing assessments of new pupils at the school, and hearing aid turnover. In addition, it will be critical to train the school teachers to help with speech acquisition as it will be so important for the children to learn to speak in their own local language and Krio (the universal Sierra Leonean language) and English, the language of education and commerce. It is a big task and may seem overwhelming. It is, however, doable with professional support and education.

In our home town of Kamloops, we have begun to work with a local organization called <u>Developing World Connections</u> (DWC). It helps to coor-

dinates projects in developing nations through local interest groups. We are now working with DWC to put together a team or teams of volunteers to support the work at the Ebert Kakua School for the Deaf. Focused on tangible results, continuity, and sustainabilty, DWC will be a good fit for the school. If Sound Seekers can do the initial hearing asssessments locally it will be a great step forward and reduce the complexities of getting equipment to Sierra Leone. However, there will be a need for therapists and hearing educators to sustain hearing needs and speech development.

# **UBC SASS:**SPECIAL OLYMPICS HOLDS HEALTHY HEARING ACROSS THE PROVINCE

Our School continues to be a strong supporter of BC Special Olympics (BCSO) Healthy Athletes program, by managing and staffing the Healthy Hearing service. Healthy Hearing is one of several services offered at most of the Healthy Athletes days, along with services from optometrists (Open Eyes), dentists/dental hygienists (Special Smiles), physiotherapists (Fun Fitness), nutritionists (Healthy Living), and others. Athletes range across a wide age spectrum, from young children to seniors. All of our audiology students take part in the event, with SLP students invited as well.

Over the past year, BCSO held Healthy Athletes events in Nanaimo, North Vancouver, Kamloops, and Prince George. We approach local community audiologists, audiometric technicians, SLPs, and HIPs before each event to inform them of the event and to recruit volunteers for the day. If you hear of a Healthy Athlete event in your community, consider volunteering – it is a worthwhile and rewarding opportunity.

Athletes are referred from the event to their family doctors based on findings of impacted cerumen or other otoscopic concerns, or flat tympanograms. Referrals to local community audiologists are made based on abnormal OAE and pure tone screen results, or a finding of hearing aids requiring service. In all, referrals are not frequent, but are important to identify, as individuals with intellectual disability are known to be underdiagnosed for hearing and other health concerns. One reason for this is the diagnostic overshadowing of

the intellectual disability itself, which can be blamed for other observed problems, such as lack of understanding verbal instructions. Out of 55 screenings at the recent event in Prince George, we made 7 referrals to community audiologists across 3 local communities. These athletes indicated they had not previously received service, either recently or at all. We also made several recommendations for cerumen removal by the family physician.

We'd love to see you at the next Healthy Athletes program in your community.

## BMS INSURANCE FROM SAC: WHAT AN OUNCE OF PREVENTION CAN DO FOR YOUR PRACTICE

Speech-language pathologists (SLPs) and audiologists need liability insurance to practice – we all know that. But when you purchase your coverage, do you think about why you need it, and how important it really is to the future of your practice? Do you know the details of the insurance you are purchasing? Are you sure that you are adequately covered and that you have the appropriate limits in place to respond to a claim?

Insurance and liability are complex subjects as are the offerings and policies that support them. It is important to understand the differences between the insurance options available in order to identify the most appropriate coverage for your practice circumstances. Although insurance is something we hope we never need, it is important to have the right coverage in place.

**Professional Liability Insurance (PLI):** Provides coverage against claims that may arise from the practice of speech-language pathology or audiology. Regulatory bodies of speech-language pathology and audiology require that every registered SLP or audiologist who provides care, whether in a paid or volunteer capacity, be covered by PLI. PLI protects SLPs and audiologists by ensuring that your legal defence is coordinated and paid for if a claim is made against you. Your PLI also covers the cost of any patient compensation, or damages. This means that your patients are also protected; because having PLI means that money is in place to compensate them for valid claims.

The Speech-Language & Audiology Canada (SAC) Professional Liability insurance program has three different insurance Plan options to choose from. Each Plan includes PLI.

While your regulatory body requires you to hold PLI, there are also other factors to consider: Are you a business owner? Incorporated? Self-employed? If so, you have other insurance considerations related to your business practice.

Legal Entity Coverage (Clinic Professional Liability): If you are incorporated or employ other therapists, assistants or communication health assistants, you should consider this additional coverage, which protects your business assets in the event that your business name is included in a statement of claim or lawsuit. Think of it as malpractice insurance for your business name. Legal Entity coverage is available as an optional extension of coverage through the SAC insurance program.

In addition to Legal Entity coverage, you may want to consider purchasing Commercial General Liability insurance, Office Contents insurance, and/or Crime Insurance to protect your other business concerns.

Commercial General Liability Insurance (CGL): Insurance that protects you against claims arising from injury or property damage that you (or your business) may cause to another person as a result of your operations and/or premises. For example, a patient may fall and injure themselves on a wet floor in your office (i.e., bodily injury as a result of your premises) – that's why CGL is so commonly referred to as "slip and fall" insurance. It's also the policy that would respond if you or your staff accidently break a patient's property while providing in-home treatment (i.e., property damage as a result of your operations).

CGL might seem like an obvious choice for business owners, but it is also recommended for SLPs and audiologists who are self-employed. If you treat or consult with patients in their homes, or contract your services to hospitals, clinics, or other health care providers, you may want to consider CGL. CGL is included in Plan 2 and Plan 3 of the SAC insurance program.

Office Contents and Crime Insurance: Business owners will also want to consider protecting their office and the contents within from losses associated with property damage (such as fire) and crime. Office Contents coverage protects against damage to property, including medical equipment, and loss of revenues caused by an interruption of business activities arising from an insured loss. Crime coverage protects against financial loss due to dishonesty, fraud, or theft of money, securities or other property owned by the office/clinic.

Office Contents insurance is included in Plan 3 of the SAC Insurance Program, while Crime coverage is available as an optional extension of coverage (Employee Fidelity Bond and Third Party Fidelity Bond). The SAC insurance program is designed by insurance experts in consultation with your national professional association. For professional liability or business insurance, nobody puts your interests first the way your national association does. With your participation, the SAC program continues to remain Canada's largest insurance program for SLPs, audiologists, and communication health assistants, protecting over 3,000 members and associates nationwide with comprehensive cost-effective coverage. ## **Public Beware**

Testing for Hearing Thresholds When You Are Wearing Hearing Aids (i.e. "Aided Hearing Thresholds")

Workers, in some employment settings, may be required to prove they are hearing (with or without hearing aids) at a certain level. Most often this is 30 dB HL at frequencies from 500 through 4000 Hz. When you, the worker, wear hearing aids, it will be important your "aided hearing thresholds" meet that requirement.

It is important **who** does the testing and **what type** of testing is done. If it is done incorrectly, it may negatively affect your employment.

Testing your aided hearing thresholds should never be done using headphones. This will likely produce invalid results. The best practice method, while you are wearing hearing aids, is to use *sound field audiometry*.

It is important for you to ask for sound field audiometry. Should the facility not provide this type of testing, please consult the CSHHPBC directory (see link below) to find an appropriate hearing healthcare professional in your area. Registered Audiologists and/or Registered Hearing Instrument Practitioners are the professionals trained in such best-practice measurements.
