### SPOTLIGHT ON SASS RESEARCH TRAINEES: ALISON BRUDERER AND XUAN ZHANG



#### Dr. Alison (Greuel) Bruderer, Postdoctoral Fellow

Dr. Alison (Greuel) Bruderer is a Postdoctoral Research Fellow in the School of Audiology and Speech Sciences at the University of British Columbia, working with Dr. Valter Ciocca in the Auditory Perception and Speech Lab. Alison came to Vancouver in 2008 for graduate school in the Psychology department at UBC, where she studied speech perception, language acquisition, and cognitive development in typically-developing infants. She completed her PhD in November 2014, and her PhD dissertation focused on the sensorimotor (articulatory) influences on the perception of speech in preverbal infants. This research showed that, well before infants speak their first words, the shape and movements of infants' articulators (the tongue and lips, specifically) interact with their abilities to perceive speech. These findings speak to theories of typical language acquisition by documenting an early-existing role for the production system in speech perception. In order to explore the implications of these findings for the clinical aspects of speech and language and to learn more about speech processing and production in adults, Alison began her Postdoctoral Fellowship with Dr. Ciocca in

January of this year. She will be investigating whether people with acquired speech disorders (such as adults with Parkinson's disease) perceive speech differently given their articulatory behaviour, and whether their production of speech sounds can be modified through increased attention to the sounds of their own utterances. In her spare time, Alison enjoys cycling, hiking, and taking road trips with friends and family. She is also an avid potter.

#### Ms. Xuan Zhang, PhD student

Xuan Zhang is a PhD student in the School of Audiology and Speech Sciences at the University of British Columbia, under the supervision of Dr. Marinova-Todd in the Bilingualism Research Lab. Xuan came to Vancouver in 2014 for her doctoral study after graduating in Ritsumeikan University in Japan, where she studied

second language acquisition, cognitive and linguistic development of bilingual speakers, as well as a brain-imaging technique called functional near-infrared spectroscopy (fNIRS). She engaged in projects assessing the development of writing and speaking skills of Japanese returnees in both languages, as well as a longitudinal study analyzing language development of simultaneous Japanese-English speakers in Japan. She completed her MA in August 2014. Her MA dissertation examined the neural bases of language switching in a Cantonese-English-Japanese trilingual speaker, with the objective of exploring the mechanisms underlying trilingual language switching using fNIRS. The results provide evidence for the Inhibitory Control Model, and indicate that language proficiency, age of acquisition, and trilingualism are possible factors that have effects on brain activation during language switching, and as such differ from previous research on late and low-proficiency bilingual participants. In order to



continue exploring the language development of bilingual speakers, Xuan started her PhD studies last year with Dr. Marinova-Todd. She is working on a large-scale four-year longitudinal project with children in early French immersion in Toronto and Vancouver, two major Canadian cities with diverse populations. The objectives of this project are to understand cross-language transfer between English and French, and to compare literacy development in English and French between multilingual children and English L1 children across multiple time points between Grade 1 and Grade 4.

Alison and Xuan are looking forward to working and learning as members of the SASS community.
